The 15th Annual Pedal Thru The Pines is a cycling event benefiting the Family Crisis Center. Participating cyclists may choose from routes of 24 miles, 40 miles, or 70 miles. Cyclists will have SAG support and will be able to make frequent stops. Riders will start from **VERNON L. RICHARDS RIVERBEND PARK, 107 HWY 71W, SMITHVILLE, TX, 78957**, at 9:00 AM and must clear the course by 4:00 PM.

Registration:

Early registration is available through March 6, 2017 with a \$40 fee. Participants must send payment and completed forms postmarked by this date or register through the online system. After this date, online registration (www.bikereg.com) is available through March 9, 2017 with a \$45 fee. Participants may also register in person at Riverbend Park, Smithville, TX from 6:30 – 8:30 AM on ride day with a \$45 fee.

Packet & t-shirt pickup for pre-registered cyclists will be at Riverbend Park, Smithville, TX from 6:30 – 8:30 AM on ride day. Early packet pick-ups will also take place in Austin @ Nelo's from 11:30am to 5:30pm. Please check the event website for location and time of early packet pickup.
